### Minutes of the Regular Meeting of the San Pablo City Council



**Monday, July 2, 2018** 

## **ROLL CALL**

The meeting convened in the Council Chambers at 6:02 pm. Present were Mayor Genoveva Garcia Calloway and Councilmembers Rich Kinney and Arturo Cruz. Vice Mayor Paul Morris arrived at 6:04 pm. Absent was Councilmember Cecilia Valdez. Also present were City Manager Matt Rodriguez, City Attorney Lynn Tracy Nerland, Assistant City Manager Reina Schwartz, Police Chief Ron Raman, Administrative Services Director Kelly Sessions, Public Works Director Jill Mercurio, City Treasurer Viviana Toledo, City Clerk Elizabeth Pabon-Alvarado, and Deputy City Clerk Lehny Corbin.

By adoption of the Consent Calendar, **Resolution 2018-098** was adopted, a Resolution of the City Council of the City of San Pablo authorizing the San Pablo Police Department to accept \$612,056 in grant funding from the California Department of Justice to participate in the Tobacco Law Enforcement Grant Program and appropriate funding in the same amount to the Police Department Budget to develop an effective, comprehensive and strategic approach to combat illegal tobacco use among minors.
