RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SAN PABLO AUTHORIZING A \$2,500 EVENT SPONSORSHIP FOR FAMILIAS UNIDAS' 2nd ANNUAL FUNDRAISING EVENT ON SEPTEMBER 8, 2018

WHEREAS, *Fiscal Resiliency Policies: Spending Cap & Facility Use Policy for Maple Hall Waivers and Spending Cap & Special Event Sponsorship (Discretionary Spending)* are adopted policy items under the FY 2018-21 Council Priority Workplan, effective November 1, 2017;

WHEREAS, this is not a project as defined by CEQA;

WHEREAS, Familias Unidas is an organization dedicated to providing quality mental health services that support the well-being for the community through preventive health education, outreach, psychosocial case management support and psychotherapy;

WHEREAS, Familias Unidas' holistic and cultural approach serves the Latino population and other diverse communities in West Contra Costa County;

WHEREAS, Familias Unidas is planning its 2nd Annual Tequila Tasting Fundraising event scheduled on Saturday, September 8, 2018 and the fundraiser will be led by Familias Unidas' Board of Directors and is part of a new strategic plan to increase philanthropic support;

WHEREAS, in 2018, Familias Unidas will donate all funds raised to sustain their programs that has been impacted by decreased funding from local, state and federal resources; and

WHEREAS, Dakota Wesleyan University requires that each student athlete find a \$400 scholarship sponsorship to assist in paying for team travel and equipment.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of San Pablo approves a sponsorship in the amount of \$2,500 to Familias Unidas.

BE IT FURTHER RESOLVED that a total of \$30,000 has been budgeted and earmarked for Special Event Annual Sponsorships under the Adopted FY 2018-21 Quadrennial Operating Budget – City Council Department. The authorized sponsorship in the amount of \$2,500 will be deducted from this expense balance leaving a remaining balance of \$19,600 for the remainder of FY 2018/19 period for future sponsorship by the City Council.
