RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SAN PABLO (1) ACCEPTING AND APPROPRIATING SB1 - LOCAL PARTNERSHIP GRANT PROGRAM FUNDS IN THE AMOUNT OF \$3,200,000 AND DESIGNATE THESE FUNDS TO THE RUMRILL BOULEVARD COMPLETE STREETS PROJECT (RUM-CST); AND (2) AUTHORIZING THE CITY MANAGER TO ENTER INTO AN AGREEMENT WITH PARK ENGINEERING, INC. FOR RUMRILL BOULEVARD COMPLETE STREETS CONSTRUCTION MANAGEMENT/INSPECTION SERVICES IN THE AMOUNT OF \$1,124,620 WITH A 15% CONTINGENCY FOR A TOTAL AUTHORIZATION OF \$1,293,313

WHEREAS, the City received a grant in the amount of \$3,200,000 for the Rumrill Boulevard Complete Streets project from the California Department of Transportation;

WHEREAS, this grant was received to modify Rumrill Boulevard to add Class II and Class IV bikeways or cycle tracks in both directions of travel, while reducing the number of vehicle travel lanes in both directions and adding left turn pockets along the corridor;

WHEREAS, the City is required to complete Construction Management/Inspection Services for the Rumrill Boulevard Complete Streets Project;

WHEREAS, this project was determined to be categorically exempt under the California Environmental Quality Act and the National Environmental Policy Act;

WHEREAS, the City issued a Request for Proposal (RFP) and Statement of Qualifications (SOQ) for Rumrill Boulevard Complete Streets Construction Management/Inspection Services on June 19, 2017;

WHEREAS, the City received submittals from three firms in response to the RFP/SOQ;

WHEREAS, after careful evaluation and interviews, staff is recommending the consultant team of Park Engineering, Inc., with sub-consultants Zoon Engineering and Applied Materials and Engineering (AME), to provide construction management/inspection services to the City; and

WHEREAS, staff is recommending that the City Council authorize the City Manager to enter into an agreement with Park Engineering Inc. for the amount of \$1,124,620 with a 15% contingency for a total authorization of \$1,293,313.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of San Pablo hereby authorizes the City Manager to accept and appropriate \$3,200,000 from the California Department of Transportation to the Rumrill Boulevard Complete Streets project and to enter into any required grant agreements and hereby authorizes the City Manager to enter into an agreement with Park Engineering, Inc. for construction management/inspection services for the Rumrill Complete Streets Project for the amount of \$1,124,620 with a 15% contingency for a total authorization of \$1,293,313.
