ROLL CALL

The meeting convened in the Council Chambers at 5:33 pm. Present were Mayor Genoveva Garcia Calloway, Vice Mayor Paul Morris and Councilmember Rich Kinney. Absent were Councilmembers Arturo Cruz and Cecilia Valdez. Also present were City Manager Matt Rodriguez, City Attorney Lynn Tracy Nerland and Deputy City Clerk Lehny Corbin.

The City Attorney reported on the Closed Session Conference with labor negotiators regarding Operating Engineers Local #3 and advised that the City Council gave directions to the labor negotiators.

ORAL COMMUNICATIONS

Cordell Hindler requested the City reach out to Community Violence Solutions to report on human trafficking at the August 6 Council meeting. He also requested that Community Services give annual reports on previous year's events, and he also commented on the Training & Travel policy.

Nevin Gill spoke regarding the new pedestrian bridge and dumping, homelessness and crime near Humboldt Avenue, as well as Restorative Justice for first-time offenders.

Janet Pottier invited City Council to the August 4, 2018 Family Fun Paint Out event at Maple Hall from 12noon to 4:00 pm, which includes San Pablo's plein air painting event in the Art Gallery.

- 2. INTRODUCTION OF NEW EMPLOYEES:
 - Community & Economic Development Director Charles Ching introduced Planning Manager Elizabeth Dunn, who thanked the Council for the opportunity.
 - City Attorney Nerland introduced her new Secretary Sara Maroof, who also expressed her appreciation for the new opportunity. Cordell Hindler spoke.

Monique August, Sponsorship Coordinator for the Tara Hills Recreation Association, spoke and thanked the City Council for their support and reported that the Pony team placed 3rd in the Northern California Division. Steve Burdo, Public Information Officer for the Contra Costa Animal Services (CCAS), gave an update through a PowerPoint presentation of the services offered by CCAS, the upcoming rate increase, the statistics of animal activities and actions taken, the pet retention program, animal adoptions, and policy updates on noisy animals and roosters. Council commented on the good customer service and response time from CCAS. Mr. Burdo responded to Council's inquiries and comments regarding the per capita rate and Police Chief Raman addressed the barking dog complaints and indicated that there would be future discussions regarding adoption of the County's Noisy Animal Ordinance. Mr. Burdo also mentioned the County's rooster ordinance for agriculturally zoned properties. City Manager Rodriguez stated the City is looking into joint licensing, microchipping and vaccination events. (#18-250)

By adoption of the Consent Calendar, **Resolution 2018-103** was adopted, a Resolution of the City Council of the City of San Pablo authorizing the City Manager to (1) execute Master Cooperative Agreement No. 13W.03 with Contra Costa Transportation Authority for Measure J Pedestrian, Bicycle and Trail Facilities (PBTF) Program funding for Rumrill Boulevard Complete Streets (RUM-CST) and Wildcat Creek Restoration and Greenway Trail Projects (WCC-TRL); (2) accept and appropriate Measure J PBTF Grant Program funding for Wildcat Creek Restoration and Greenway Trail (\$1,000,000) and Rumrill Boulevard Complete Streets Phase II (\$1,000,000); and (3) accept and appropriate Measure J Transportation for Livable Communities (TLC) grant funding for Wildcat Creek Restoration and Greenway Trail (\$280,000).
