RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SAN PABLO SETTING A PUBLIC HEARING FOR OCTOBER 15, 2018 ON AN ORDINANCE AMENDING CHAPTER 6.04 OF THE SAN PABLO MUNICIPAL CODE REGARDING ANIMAL CONTROL INCLUDING ADOPTION BY REFERENCE OF CHAPTERS 416-2 TO 416-12 OF DIVISION 416 OF THE CONTRA COSTA COUNTY CODE, "ANIMALS" WITH THE EXCEPTION OF ARTICLE 416-12.10

WHEREAS, the City of San Pablo and Contra Costa County have a long-standing agreement for Contra Costa County to provide animal control services within San Pablo by the County's Animal Services Department;

WHEREAS, the Board of Supervisors of County of Contra Costa has adopted County ordinances with provisions for animal control services, which are codified at Chapters 416-2 to 416-12 of Division 416 of the County Code and referred to collectively as "County Animal Control Ordinance;"

WHEREAS, since 2006, the County has amended and added ordinances that are not reflected in Chapter 6.04 of the City's Municipal Code;

WHEREAS, both City and County staffs recommend updating the City's Municipal Code to reflect these more recent County ordinances to allow County Animal Services the ability to enforce these ordinances within San Pablo with the exception of the County provision regarding regulating the keeping of roosters are roosters are prohibited in San Pablo; and

WHEREAS, the California Government Code sets forth specific procedures for a city to adopt by reference the code or ordinance of another jurisdiction, including the City Council introducing the ordinance and setting a public hearing before the adoption of the ordinance.

NOW, THEREFORE, BE IT RESOLVED that the foregoing recitations are true and correct, and are included herein by reference as findings; and

BE IT FURTHER RESOLVED that the City of San Pablo City Council.sets a public hearing for Monday, October 15, 2018 at 6:00 p.m. or thereafter in the course of the regular City Council agenda to consider adoption of the ordinance to amend Chapter 6.04 of the San Pablo Municipal Code regarding animal control including adoption by reference of Chapters 416-2 to 416-12 of Division 416 of the Contra Costa Code, "Animals" with the exception of Article 416-12.10, "Roosters."
