RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SAN PABLO AMENDING THE FY 2018-21 CITY COUNCIL PRIORITY WORKPLAN TO AUTHORIZE CITY-WIDE NOISE AND TRAFFIC STUDIES TO BE INCORPORATED INTO THE GENERAL PLAN UPDATE 2020 PROCESS

WHEREAS, the City Council Adopted Priority Workplan (Adopted Workplan) is a culmination of previous goal-setting and strategic planning sessions involving previous and current City Council, City Manager, Executive Leadership Group members, and shall be annually updated to reflect current City Council priorities and policy areas;

WHEREAS, on October 1, 2018, the City Council received extensive public comment from residents on the impacts of noise from increased intensity of uses on neighborhoods adjacent to the Giant Road and BNSF Railroad corridor along the border with the City of Richmond;

WHEREAS, the City Manager has indicated that the City will be initiating the City's General Plan Update 2020 during FY 2018/19 as required by State law, and recommends that "City-wide Noise and Traffic Studies" be formally incorporated into the forthcoming City's General Plan Update 2020 process to be conducted and implemented concurrently following the adoption of the City's Zoning Code Amendment process currently underway; and

WHEREAS, the City Manager recommends an existing policy item in the Adopted Workplan be amended to include "City-wide Noise and Traffic Studies".

NOW THEREFORE, BE IT RESOLVED the City Council of the City of San Pablo hereby amends the FY 2018-21 City Council Priority Workplan effective this date, to read as follows:
