Amount Requested

\$325 (\$25 per San Pablo resident student)

Use of Funds

The funds will be used to introduce and reinforce basic musicianship skills through Kodaly methodology with the purpose of preparing the singers to sing music in the intermediate and difficult levels. According to the Music Educators Journal, the Kodaly method is a research based method proven to "improve intonation, rhythm skills, music literacy, and the ability to sing in increasingly complex parts. Outside of music, it has shown to improve perceptual functioning, concept formation, motor skills, and performance in other academic areas such as reading and math."

The funds will be used for the purchase of materials. These materials have a life expectancy of 10+ years.
