

**NOTICE IS HEREBY GIVEN** that the City Council of the City of San Pablo will hold a public hearing on **Monday, December 3, 2018, at 6:00 pm** in the City Council Chambers located at City Hall, 13831 San Pablo Avenue, San Pablo, San Pablo, California, to consider and act upon the following:

A request by Richmond Sanitary Service for the City of San Pablo to establish maximum solid waste (trash, recycling, and organics) rates effective January 1, 2019 and future CPI changes not to exceed 5% effective January 1, 2020-2022. The City oversees the collection charges and the West Contra Costa Integrated Waste Management Authority (RecycleMore) oversees post collection charges.
