

RESOLUTION 2018-154

RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SAN PABLO RECITING THE FACT OF THE GENERAL MUNICIPAL ELECTION HELD IN THE CITY OF SAN PABLO ON THE 6TH DAY OF NOVEMBER, 2018, DECLARING THE RESULT THEREOF AND SUCH OTHER MATTERS AS ARE PROVIDED BY LAW

WHEREAS, a general municipal election was held and conducted in the City of San Pablo, County of Contra Costa, State of California on Tuesday, the 6th day of November, 2018, as required by law;

WHEREAS, notice of the election was duly and regularly given in time, form and manner as provided by the law; that voting precincts were properly established; that election officers were appointed and that in all respects the election was held and conducted and the votes cast, received and canvassed and the returns made and declared in time, form and manner as required by the provisions of the Elections Code of the State of California for the holding of elections in cities;

WHEREAS, the County Clerk of the County of Contra Costa canvassed the returns of the election and has certified the results to the City Council, the results are received, attached and made a part thereof as "Exhibit A."

NOW, THEREFORE, BE IT RESOLVED, the City Council of the City of San Pablo hereby resolves as follows:

SECTION 1. That there were ten (10) voting precincts established for the purpose of holding the election consisting (of consolidation) of the regular election precincts in the City of San Pablo as established for the holding of state and county elections.

SECTION 2. That the regular municipal election was held for the purpose of electing the following officers of said City as required by the laws relating to cities in the State of California:

Two members of the City Council of the City of San Pablo for full term of four years;
City Clerk of the City of San Pablo for full term of four years; and
City Treasurer of the City of San Pablo for full term of four years.

SECTION 3. Exhibit A from the County Elections Department describe the votes cast and names of persons voted for in the November 6, 2018 election, and is attached and incorporated into this resolution.

SECTION 4. The City Council does declare and determine that:

Rita Xavier was elected as a member of the City Council of the City of San Pablo for the full term of four years;

Elizabeth Pabon-Alvarado was elected as a member of the City Council of the City of San Pablo for the full term of four years;

Patricia Ponce was elected as City Clerk for the City Council of said City for the full term of four years;

Viviana Toledo was elected as City Treasurer for the City Council of said City for the full term of four years;

SECTION 5. The City Clerk shall enter this information into the records of the City Council of San Pablo.

SECTION 6. That the City Clerk shall immediately make and deliver to each of such persons so elected a Certificate of Election signed by him/her and duly authenticated; that the City Clerk shall also administer or have administered to each person elected the Oath of Office prescribed in the State Constitution of the State of California; and shall have them subscribe to and file the same in his/her office. Whereupon, each and all of persons so elected shall be inducted into the respective office to which they have been elected.

SECTION 7. That the City Clerk shall certify to the passage and adoption of this resolution; shall enter the same in the book of original Resolutions of said City; and shall make a minutes of the passage and adoption thereof in the records of the proceedings of the City Council of said City, in the minutes of the meeting at which the same is passed and adopted.

IT IS FURTHER RESOLVED that the foregoing recitations are true and correct, and are included hereby reference as findings.
