RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SAN PABLO TO DECLARING CERTAIN POLICE DEPARTMENT VEHICLES AS SURPLUS PROPERTY AND AUTHORIZING THE DISPOSAL OF THE FORD CROWN VICTORIA PURSUANT TO SAN PABLO MUNICIPAL CODE SECTION 3.16.120 AND DONATION OF THE FORD VAN TO CONTRA COSTA COLLEGE AUTOMOTIVE PROGRAM

WHEREAS, "Foster College and Career Readiness, Education, Youth Leadership, and City/Contra Costa College/WCCUSD Partnership" is an adopted policy priority under the FY 2019-21 Council Priority Work plan, effective March 1, 2019;

WHEREAS, this proposed action is not a project under CEQA pursuant to Guidelines Section 15378(b)(5): Organizational or administrative activities of governments that will not result in direct or indirect physical changes in the environment, but if deemed a project, then under CEQA Guidelines § 15061(b)(3), in that it can be seen with certainty that there is no possibility that the activity in question may have a significant effect on the environment:

WHEREAS, Police vehicle #847 (2007 Ford van) used for prisoner transport requires a new engine and the cost of repair (\$9,000) outweighs the actual value of the van (approximately \$1,000);

WHEREAS, rather than sell van for salvage value pursuant to San Pablo Municipal Code section 3.16.120, the Police Department recommends donating it to the Contra Costa College Automotive program for classroom training consistent with the City Council's policy priority to deepen the relationship with Contra Costa College and foster college and career readiness in our community;

WHEREAS, Police vehicle #829, an unmarked 2003 Ford Crown Victoria, requires repairs exceeding \$4,000 and such costs outweigh the actual value of the vehicle (approximately \$1,000); and

WHEREAS, the Police Department desires to declare the Ford Crown Victoria surplus property and dispose of it pursuant to San Pablo Municipal Code section 3.16.120, through an auction or online.

NOW, THEREFORE, BE IT RESOLVED that the foregoing recitations are true and correct, and are included herein by reference as findings; and

BE IT FURTHER RESOLVED that the City of San Pablo City Council authorizes the disposal of Police Department vehicle #829 by auction or online with the proceeds allocated to City account 100-2110-39202; and

BE IT FURTHER RESOLVED that the City Council authorizes the disposal of Police Department vehicle #847 by donating it to the Contra Costa College Automotive program.
