

## RESOLUTION 2019-108

### RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SAN PABLO AUTHORIZING A FEE WAIVER IN THE AMOUNT OF \$6,150 FOR THE SAN PABLO COWBOYS YOUTH ASSOCIATION (SPCYA) USE OF DAVIS PARK SPORTS FIELDS AND CONCESSION STAND FOR THE 2019 SUMMER/FALL SEASON

WHEREAS, *Expand safe, family-friendly park space* and *Improve connections to healthy eating and active living* are adopted priority items under the FY 2019-21 City Council Priority Work plan, effective March 1, 2019;

WHEREAS, on May 9, 2019 Andre Williams, President of SPCYA, submitted a letter to the City Staff requesting City Council waive fees for Davis Park (Multi-Use and Mini Sports Fields) and the Davis Park Concession Stand on the following dates and times:

#### **Davis Park Sport Fields (Multi-Use Sports Field and Mini Sports Field)**

- July 22, 2019 – December 15, 2019 (Monday–Friday 6:30PM–8:30PM)
- Exceptions include City Holidays/Closure Dates

#### **Davis Park Concession Stand**

- July 22, 2019 – December 15, 2019 (Monday–Friday)
- Exceptions include City Holidays/Closure Dates

WHEREAS, SPCYA offers a diverse football program that provides approximately 200 San Pablo youth the ability to travel to numerous cities and compete against various football programs. Participants are rewarded for their accomplishments in athletics as well as scholastics to assure them that they are always winners just for taking the initiative to do their best;

WHEREAS, organizations requesting fee waivers need to submit supporting paperwork such as articles of incorporation, updated roster/membership, list of organization officers and contact information, certificate of insurance, and copy of the organizations by-laws;

WHEREAS, according to the SPCYA current rosters, they have approximately 88 youth athletes enrolled in their program. Of those 88 enrollees, 22% or 19 of those youth athletes reside within the City of San Pablo.

WHEREAS, the fiscal impact for FY 2019/20 (2019 summer/fall season) will be subsidizing approximately \$6,450 in rental revenue for Davis Park Sport Fields and Concession Stand;

WHEREAS, the Application Fee and the Damage/Cleaning Deposit are not eligible for a fee waiver;

WHEREAS, this is not a project as defined by CEQA; and

WHEREAS, this item was taken before the Community Services Standing Committee (Xavier/Cruz) on June 19, 2019 where they unanimously supported the recommendation to move forward to City Council to approve the fee waivers requested by San Pablo Cowboys Youth Association for the summer/fall season ending December 15, 2019.

NOW, THEREFORE, BE IT RESOLVED that the foregoing recitations are true and correct, and are included herein by reference as findings.

BE IT FURTHER RESOLVED the City Council of San Pablo authorizes the City Manager to waive the field rental fees for the San Pablo Cowboys Youth Association for the use of the Davis Park Fields and Concession Stand for the 2019 summer/fall season as described above in the amount of approximately \$6,150.
