RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SAN PABLO AUTHORIZING A \$2,500 EVENT SPONSORSHIP FOR *FAMILIAS UNIDAS*, 40<sup>TH</sup> ANNIVERSARY FUNDRAISING EVENT ON SATURDAY, OCTOBER 5, 2019

WHEREAS, *Build a Healthy Community* is an adopted policy item on the FY 2019-21 City Council Priority Work plan, effective March 1, 2019;

WHEREAS, this is not a project as defined by CEQA;

WHEREAS, Familias Unidas is an organization dedicated to providing quality mental health services that support the well-being for the community through preventive health education, outreach, psychosocial case management support and psychotherapy;

WHERAS, Familias Unidas' holistic and cultural approach serves the Latino population and other diverse communities in West Contra Costa County;

WHEREAS, Familias Unidas will be celebrating its 40<sup>th</sup> Anniversary at a fundraising event on Saturday, October 5, 2019 at the Assemble Restaurant located at the Craneway Pavilion in Richmond:

WHEREAS, the fundraiser will be led by Familias Unidas' Board of Directors and is part of a new strategic plan to increase philanthropic support and will donate all funds raised to sustain their programs which have been impacted by decreased funding from local, state and federal resources that directly benefits families of San Pablo;

WHEREAS, with the support of the City of San Pablo has resulted in Familias Unidas being able to provide 500 primarily uninsured families with mental health and violence prevention services annually.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of San Pablo approves a sponsorship in the amount of \$2,500 to Familias Unidas;

BE IT FURTHER RESOLVED a total of \$30,000 has been budgeted and earmarked for Special Event Annual Sponsorships under the Adopted FY 2018-21 Quadrennial Operating Budget – City Council Department. The authorized sponsorship in the amount of \$2,500 will be deducted from this expense balance leaving a remaining balance of \$26,400 for the remainder of FY 2019/20 period for future sponsorship by the City Council.
