In the event that any merchandise proves to be defective within the warranty period, MTA will repair or, at MTA's option, replace the defective merchandise, which in MTA's opinion, has not been damaged by accident, misuse, or neglect. In the event that any merchandise proves defective, PURCHASER'S sole remedy shall be the repair or replacement provided for in this warranty. UNDER NO CIRCUMSTANCES SHALL MTA BE LIABLE TO ANY PERSON FOR LOSS OR DAMAGE DIRECT, INCIDENTAL, OR CONSEQUENTIAL, ARISING FROM THE USE OF OR INABILITY TO USE THE MERCHANDISE. MTA DISCLAIMS ALL EXPRESS WARRANTIES IN CONNECTION WITH MERCHANDISE PROVIDED UNDER THIS CONTRACT EXCEPT AS STATED ABOVE. THERE ARE NO WARRANTIES WHICH EXTEND BEYOND THE DESCRIPTION ON THE FACE OF THIS CONTRACT. MTA DISCLAIMS ANY IMPLIED WARRANTY OF MERCHANTABILITY OF THE MERCHANDISE OR OF FITNESS FOR ANY PURPOSE, AND PURCHASER AGREES THAT THE MERCHANDISE IS SOLD "AS IS".
7. Unless otherwise requested, MTA will deliver all merchandise to the address PURCHASER has specified, which is shown on the face of this contract. PURCHASER agrees to pay MTA a reasonable storage charge of fifty-five cents per square foot per month, plus loading and unloading charges for any tendered merchandise which MTA stores at MTA's warehouse provided space is available, because of PURCHASER'S failure to accept delivery.
8. In the event PURCHASER elects to engage the services of MTA to perform installation work at the project site ("Project Site") designated on the front of this contract the undersigned parties agree as follows:
 - 8.1 MTA shall perform the installation work ("Work") described on the face of this contract in a diligent, thorough and workmanlike manner pursuant to the plans and specifications furnished by PURCHASER to MTA prior to the effective date of this contract.
 - 8.2 PURCHASER shall pay the price ("Installation Price") designated on the face of this contract for the Work in accordance with section 9 below.
 - 8.3 PURCHASER shall perform the following covenants at PURCHASER'S expense:
 - 8.3.1 Furnish upon MTA's request all evidence of titles, permits, and insurance documents as may be necessary for the Work;
 - 8.3.2 Provide names and addresses for all construction lenders and the project manager of project;
 - 8.3.3 Provide all plans, drawings, specifications, services, information, surveys, and reports pertaining to the Work as requested by MTA;
 - 8.3.4 Maintain adequate liability or course of construction insurance;
 - 8.3.5 Prepare the Project Site so that MTA is able to perform the Work without undue hindrance;
 - 8.3.6 Provide suitable space for the receipt and storage of materials and equipment; and,
 - 8.3.7 Be available for inspection and acceptance of all Work.
 - 8.4 Should PURCHASER make or request any modification in the Plans, specifications or Work, all such modifications shall be authorized by written change order approved by PURCHASER and MTA describing the modification. The written change order shall set forth any increase or decrease in the Installation Price, if any, caused by such modification. PURCHASER acknowledges that any modification in the plans, specifications or Work may delay completion of the work and result in a substantial increase in the Installation Price.
 - 8.5 MTA may terminate its performance of this contract at its option by giving written notice of termination to PURCHASER if: PURCHASER is adjudged bankrupt; PURCHASER becomes insolvent or has a receiver of its assets or property appointed because of insolvency; PURCHASER fails to cooperate with MTA in performance of the Work; PURCHASER defaults in the payment of any invoiced amount; or, MTA is delayed in performing the Work for a period which, in the aggregate, exceeds ten (10) days as the result of any cause or combination of causes described in section 8.6 below.

- 8.6 MTA shall not be responsible for delays in completion of the Work caused by PURCHASER'S failure to prepare the Project Site, delay in shipment or receipt of materials, strikes, acts of God, fire or other casualty, labor disputes, neglect or fault of PURCHASER or PURCHASER'S materials, weather or other conditions beyond MTA's control.
- 8.7 The Work shall conform to all applicable City, County, State or Federal laws, regulations, codes, requirements, permits, ordinances and inspections.
- 8.8 PURCHASER hereby undertakes and agrees, at PURCHASER'S cost, to defend, indemnify and hold harmless MTA and each of MTA's associates, owners, stockholders, subsidiaries, affiliates, partners, joint venturers, predecessors, successors, assigns, agents, directors, officers, employees, representatives, attorneys, and all persons acting by, through, under or in concert with them or MTA, or any of them, from and against any and all manner of claims, causes, causes of action, damages, losses, liabilities, costs and expenses (including attorneys' fees), however caused and of whatsoever kind or character, directly or indirectly arising out of or in connection with the Work and/or the Project Site, including but not limited to the acts or negligent omissions of PURCHASER'S agents, employees or contractors, except for the negligent acts or omissions of MTA.
- 8.9 PURCHASER covenants and agrees to comply fully with all applicable City, County, State, and Federal safety laws, regulations, codes, requirements, permits, ordinances, and inspections. PURCHASER undertakes and agrees, at PURCHASER'S cost, to defend, indemnify and hold harmless MTA and each of MTA's associates, owners, stockholders, subsidiaries, affiliates, partners, joint venturers, predecessors, successors, assigns, agents, directors, officers, employees, representatives, attorneys, and all persons acting by, through, under or in concert with them or MTA, or any of them, from and against any and all manner of claims, causes, causes of action, damages, losses, liabilities, costs and expenses (including attorneys' fees), however caused and of whatsoever kind of character, directly or indirectly arising out of or in connection with PURCHASER'S violation of any applicable City, County, State or Federal safety laws, regulations, codes, requirements, permits, ordinances and inspections.

9. Payments under this contract are due and payable within payment terms stated on proposal based on invoiced date. In the event MTA does not receive full payment when due, PURCHASER agrees to pay interest at the highest allowable rate on the unpaid balance from due date until paid in full. This interest charge shall in no way signify that MTA consents to deferred payment.
10. Any dispute or controversy arising under, out of, in connection with or in relation to this contract, and any amendments hereto, or the breach thereof, shall be determined and settled by arbitration to be held in the City and County of Sacramento, California, in accordance with the rules then obtaining of the American Arbitration Association. Any award rendered therein shall be final and binding upon each and all of the parties and judgment may be entered thereon in any court having jurisdiction thereof.
11. In the event any legal action or arbitration proceeding arises between the undersigned parties concerning this contract, the prevailing party shall be entitled to reasonable attorneys' fees in addition to all other costs and expenses incurred therein. PURCHASER promises to pay attorneys' fees and all other costs incurred by MTA in the collection of payments due under this contract.
12. The covenants and conditions herein contained shall inure to and bind the successors and assigns of the parties hereto. PURCHASER shall not assign this contract without the prior written consent of MTA.
