RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SAN PABLO CITY COUNCIL AMENDING THE FY 2019-21 ADOPTED CITY COUNCIL PRIORITY WORKPLAN UNDER MAJOR POLICY GOAL: BUILD A HEALTHY COMMUNITY TO ADD PET WASTE RECEPTACLES AND DISPOSAL BAG PROGRAM FOR CITY PARKS FOR FY 2020/21

WHEREAS, on March 1, 2019, the City Council adopted Resolution 2019-029 which amended the FY 2019-21 City Council Priority Workplan; and

WHEREAS, the City Council may periodically amend the FY 2019-21 City Council Priority Workplan (Workplan) to add or eliminate policy items by majority vote via adopted Resolution; and direct the City Manager on policy and/or program implementation; and

WHEREAS, on motion made by Mayor Kinney, duly seconded, the City Council directed by majority vote at the August 5, 2019 City Council Meeting to agendize a City Council policy discussion to consider amending the adopted Workplan to include the following policy item under *Major Policy Goal: Build a Healthy Community*, as follows:

Under Major Policy Goal:

Build a Healthy Community

Add Policy Item: #100.18

Explore annual funding and study for a pet waste receptacle and disposal bag program for City Parks for FY 2020/21 program implementation

WHEREAS, following City Council policy discussion, the City Council desires to formalize this amendment to the Workplan by said Resolution attached hereto, and to direct the City Manager to explore potential funding sources, and to conduct an operational study during FY 2019/20 for future program implementation in FY 2020/21; and

WHEREAS, a program analysis and study during FY 2019/20 would address the community and operational need for pet waste receptacles and disposal bags with all cost and operational considerations identified for potential FY 2020/21 program implementation in Davis Park, and/or other City park facilities, if warranted;

WHEREAS, the City Manager has outlined a number of preliminary policy considerations that would be components of a program analysis/study during FY 2019/20, including but not limited to, the following:

- Quantity of Receptacles and Disposal Bags Needed and Funding for their Acquisition
- Annual Operating and Maintenance Program Costs
- Identification of Specific City Parks and High Impact Areas
- Need for Park User Signage (bi-lingual)
- Potential Vandalism Impacts
- Community Feedback (i.e. *Social Media and/or Annual City Survey in December 2019*)

NOW, THEREFORE, BE IT RESOLVED the City Council of the City of San Pablo authorizes the following, as follows:

1. Amend the FY 2019-21 Council Priority Workplan to include:

Major Policy Goal:

Build a Healthy Community

Add Policy Item: #100.18

Explore annual funding and study for a pet waste receptacle and disposal bag program for City Parks for FY 2020/21 program implementation

2. Direct the City Manager to explore potential funding sources and to conduct an operational study for future program implementation. A program analysis and operational study would be recommended by the City Manager during FY 2019/20 to address the community and operational need for pet waste receptacles and disposal bags, with all cost and operational considerations identified for potential FY 2020/21 program implementation in Davis Park, and/or other City park facilities, if warranted;
3. Additional feedback would be solicited from an appropriate City Council Standing Committee (i.e. Budget, Fiscal & Legislative) with a recommendation to the City Council for formal program implementation prior to FY 2020/21.

BE IT FURTHER RESOLVED that the foregoing recitations are true and correct, and are included herein by reference as findings.
