RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SAN PABLO AUTHORIZING AN EVENT SPONSORSHIP IN THE AMOUNT OF \$1,000 FOR THE ROTARY CLUB OF SAN PABLO'S 13<sup>TH</sup> ANNUAL HOLIDAY EVENT ON SATURDAY, DECEMBER 21, 2019

WHEREAS, *Build a Healthy Community and Civic Engagement are* adopted policy items under the FY 2019-21 Council Priority Workplan, effective March 1, 2019;

WHEREAS, since the initial request, the venue and date of the event have changed and will be held in the County Brookside Shelter Facility on Saturday, December 21, 2019;

WHEREAS, this holiday season the San Pablo Rotary Club will donate bikes, helmets, hats and scarfs, care packages and a host of other items to the Brookside Shelter and Calli's House;

WHEREAS, the San Pablo Rotary Club members and other volunteers use this opportunity for civic engagement by giving back to the San Pablo community during the holiday season; and

WHEREAS, the Rotary Club has also partnered with Read Aloud Books and also extends an invitation to San Pablo staff to participate.

NOW, THEREFORE, BE IT RESOLVED that the City Manager is authorized to issue an event sponsorship in the amount of \$1,000 to the San Pablo Rotary Club for their 13<sup>th</sup> Annual Holiday event to be held on Saturday, December 21, 2019.

BE IT FURTHER RESOLVED, FY 2018-21 Four-Year Quadrennial Operating Budget – City Council Department (100-1110-44050). The authorized event sponsorship in the amount of \$1,000 will be deducted from this expense balance leaving a remaining balance of \$7,900 for the remainder of the FY 2019/20 period for future sponsorships by the Council.
