RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SAN PABLO RATIFYING THE PURCHASE OF UPS SYSTEMS FOR THE DATA CENTER AT THE NEW CITY HALL FROM GRAYBAR ELECTRIC COMPANY INC. AT A TOTAL PRE-TAX AND PRE-FREIGHT COST OF \$63,744 THROUGH A COOPERATIVE PURCHASING ARRANGEMENT WITH THE US COMMUNITIES GOVERNMENT PURCHASING ALLIANCE

WHEREAS, Enhance Community Resilience and Strengthen Technological Infrastructure are adopted policy items under the FY 2019-21 Council Priority Workplan, effective March 1, 2019;

WHEREAS, a key component of any computer data center is backup "uninterruptible power supply" (UPS) systems to provide power to critical computer systems in the event of a power loss, such that the UPS system provides a temporary source of power to allow for the safe and graceful shutdown of systems to prevent damage to computer and network hardware;

WHEREAS, UPS systems will be situated in the data center at the new City Hall, but due to tight construction timelines and the holiday closure in December 2019, the purchase order was processed before the end of the calendar year without City Council approval to keep the project on schedule and help avoid potential delays in City Hall construction and completion;

WHEREAS, the purchase was executed in accordance with City of San Pablo Municipal Code chapter 3.16, pursuant to the cooperative purchasing exemption in section 3.16.110(E) which allows the City to join with other governmental agencies for the joint purchase of equipment, materials, supplies and services or to buy from another public agency's competitive contract without the City undertaking its own competitive bidding process;

WHEREAS, the City of Kansas City (the lead public agency awarding contract #EV2370) signed a master agreement allowing itself and other agencies in the United States, including local governments, access to a comprehensive, competitively solicited offering of products and services through a contract with Graybar Electric Company Inc. registered with the US Communities Government Purchasing Alliance; and

WHEREAS, the onetime cost of the UPS system is \$63,743.69 before freight and tax, which expense is already funded and will be paid from new City Hall project funding (320-3200-46300-CIH-CON).

NOW, THEREFORE, BE IT RESOLVED that the foregoing recitations are true and correct and are included herein by reference as findings.

BE IT FURTHER RESOLVED that the City Council of the City of San Pablo ratifies the purchase of UPS systems for the data center at the new City Hall from Graybar Electric Company Inc. at a cost of \$63,743.69 plus freight and taxes through a cooperative purchasing arrangement with the US Communities Government Purchasing Alliance, pursuant to the terms in the contract attached as Exhibit 1.
