RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SAN PABLO ACCEPTING WORK PERFORMED BY BAY CITIES PAVING AND GRADING, INC. FOR THE FY 2018/19 PAVEMENT REPAIR PROJECT (MAR-600) AS COMPLETE AND DIRECTING THAT A NOTICE OF COMPLETION BE PREPARED AND FILED WITH THE COUNTY RECORDER

WHEREAS, the FY 2018/19 Pavement Repair Project (MAR-600) is part of the City's ongoing pavement maintenance program in the capital projects budget;

WHEREAS, the FY 2018/19 Pavement Repair Project consists of, but is not limited to, base failure repairs of existing asphalt concrete, grinding and overlaying the existing asphalt concrete pavement with conventional asphalt concrete, reconstructing concrete curb ramps, conducting traffic control and restoration of striping and pavement markings;

WHEREAS, the City of San Pablo filed a CEQA Notice of Exemption for the project with the Contra Costa County on April 25, 2019;

WHEREAS, on April 15, 2019, through Resolution 2019-056, the City Council awarded the contract to Bay Cities Paving & Grading, Inc., Concord, CA for a bid amount of \$1,206,109 and authorized a project budget of \$1,387,025 for construction;

WHEREAS, the project was completed for a final cost of \$1,151,624;

WHEREAS, with the closing of the project, the remaining balance of \$303,620 will be returned to source (the General Fund) per best management practices; and

WHEREAS, the City is holding 5% retention on this project. When the Notice of Completion is approved, the City will pay out the retention and close out the project.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of San Pablo hereby:

- 1. Accepts work performed by Bay Cities Paving & Grading, Inc. for the FY 2018/19 Pavement Repair Project (MAR-600) as complete.
- 2. Directs that a Notice of Completion be prepared and filed with the County Recorder for the FY 2018-19 Pavement Repair Project (MAR-600).
