

## RESOLUTION 2020-009

**RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SAN PABLO AUTHORIZING THE CITY MANAGER TO (1) ACCEPT \$40,000 IN KAISER PERMANENTE GRANT FUNDING FOR A REGIONAL COORDINATED OUTREACH, REFERRAL AND ENGAGEMENT (C.O.R.E.) HOMELESS OUTREACH TEAM TO IDENTIFY, ENGAGE AND CONNECT PERSONS EXPERIENCING HOMELESSNESS TO HEALTHCARE, SOCIAL SERVICES AND HOUSING; (2) ENTER INTO AN AMENDED AGREEMENT WITH CONTRA COSTA HEALTH SERVICES TO PROVIDE C.O.R.E. SERVICES FOR ONE YEAR AT A COST NOT TO EXCEED \$40,000; AND (3) APPROPRIATE FUNDING IN THE SAME AMOUNT TO THE POLICE DEPARTMENT BUDGET IN SUPPORT OF THE PROGRAM**

WHEREAS, Homeless Services & Illegal Encampment Enforcement is an adopted policy item under the FY 2019-21 City Council Priority Work plan, effective March 1, 2019;

WHEREAS, this is not a project as defined by CEQA;

WHEREAS, in February 2018, the San Pablo Police Department began the P.A.T.H. (Partnership in Assisting the Transition from Homelessness) Program due to a larger number of people experiencing homelessness in Contra Costa County, specifically in the City of San Pablo;

WHEREAS, on October 2, 2018, City Council adopted a resolution declaring a shelter crisis in San Pablo pursuant to SB850 (Resolution 2018-128);

WHEREAS, in 2018, the San Pablo Police Department was invited by Kaiser Permanente to apply for the Kaiser Permanente Community Benefits Program Grant for \$60,000 to support a Regional West Contra Costa County CORE (Coordinated Outreach Referral, Engagement) Team for the cities of San Pablo and Richmond;

WHEREAS, Kaiser Permanente subsequently awarded the funds to the City of San Pablo;

WHEREAS, on January 22, 2019, the City Council authorized the acceptance of the \$60,000 and for the City Manager to enter into a service agreement contract with Contra Costa Health Services to provide CORE services in San Pablo for one year (Resolution 2019-003);

WHEREAS, in 2019, the San Pablo Police Department was again invited by Kaiser Permanente to apply for the Kaiser Permanente Community Benefits Program Grant for \$40,000 to support a Regional West Contra Costa County CORE Team for the cities of San Pablo and Richmond;

WHEREAS, Kaiser Permanente has subsequently awarded the funds to the City of San Pablo;

WHEREAS, CORE services will continue to include canvassing to identify, engage, and connect persons experiencing homelessness to healthcare, social services, and housing;

WHEREAS, the City of San Pablo supports the grant goals and wishes to participate in the West Contra Costa County Regional CORE Team;

WHEREAS, the Police Department will continue to collaborate with Contra Costa Health Services and the City of Richmond to prioritize the needs of our community with 16 hours of the 40-hour work week specifically committed in the City of San Pablo;

WHEREAS, the term of the proposed FIRST AMENDMENT to the original CORE AGREEMENT is December 1, 2019 through November 30, 2020; and

WHEREAS, the \$40,000 in grant funding would be accepted into the Police Grants revenue account (100-2110-33405-KSR-HOM) and appropriated to the Professional Services account (100-2110-43600-KSR-HOM). Any unforeseen costs of the program will be absorbed within the exiting Police Department budget.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of San Pablo hereby:

- (1) Authorizes the acceptance of \$40,000 in grant funding from the Kaiser Permanente Community Benefits Program into the Police Department's grant revenue account (100-2110-33405-KSR-HOM); and
- (2) Authorizes the appropriation of \$40,000 to the Police Department's Professional Services account (100-2110-43600-KSR-HOM) to fund CORE services for one year; and
- (3) Authorizes the City Manager to enter into the amended service agreement contract with Contra Costa County Health Services to provide CORE services in San Pablo for one year at a not-to-exceed cost of \$40,000 as set forth in the attached Exhibit 1 with any unforeseen costs of the program will be absorbed within the existing Police Department budget.
