CITY OF SAN PABLO NOTICE OF PUBLIC HEARING February 3, 2020

NOTICE IS HEREBY GIVEN that the City Council of the City of San Pablo, State of California, will hold a public hearing on the following item:

PLAN2001-0007, Amendment to Section 8.36 of the City of San Pablo Municipal Code relating to the citywide prohibition of smoking in rental multi-unit housing. Consideration to amend Section 8.36 of the City of San Pablo Municipal Code, No-Smoking Regulations, to prohibit smoking in rental multi-unit housing citywide. This is a City-initiated project pursuant to a City Council FY 2010-21 Workplan item to build a healthy community, adopted March 1, 2019.

Pursuant to the California Environmental Quality Act (CEQA), the proposed ordinance is categorically exempt based on Section 15321, Enforcement Actions by Regulatory Agencies. Class 21 exemptions consist of: (a) Actions by regulatory agencies to enforce or revoke a lease, permit, license, certificate, or other entitlement for use issued, adopted, or prescribed by the regulatory agency or enforcement of a law, general rule, standard, or objective, administered or adopted by the regulatory agency. Additionally, Section 15268(b)(2), Ministerial Projects, also applies, as the issuance of a business license is seen as a ministerial act by a City.

NOTICE IS HEREBY FURTHER GIVEN that the hearing will be at the hour of 6:00 p.m. in the City Council Chambers located at One Alvarado Square, 13831 San Pablo Avenue, San Pablo, CA, 94806 at which time and place all persons interested may appear and comment.
