NOTICE OF AMENDMENT TO THE SAN PABLO MUNICIPAL CODE

SUMMARY OF AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF SAN PABLO AMEND-ING CHAPTER 8.36 OF THE SAN PABLO MUNICI-PAL CODE RELATING TO THE CITYWIDE PRO-HIBITION OF SMOKING IN RENTAL MULTI-UNIT HOUSING

The following is a summary of major highlights of the ordinance: a reading of the entire ordinance may be necessary to obtain a full understanding of all changes. A certified copy of the full text of the ordinance is posted and may also be read in the City Clerk's Office, City Hall, 13831 San Pablo Avenue, San Pablo, CA (510-215-3005). The ordinance was introduced at the City Council meeting of February 3, 2020 and is scheduled for adoption at the February 18, 2020 City Council meeting. The ordinance amends Chapter 8.36 of the City of San Pablo Municipal Code to prohibit smoking in rental multi-unit housing citywide, and requires landlords to post no-smoking signs in common areas, notify tenants, and amend leases.
