Free Waste Disposal Services (for San Pablo Residents)

- Dump Voucher Program \$60 of dump vouchers per fiscal year for disposal at 1 Parr Blvd.,
 Richmond
- Waste Drop Off (Dumpster Days) disposal of trash at 2600 Moraga Rd., San Pablo on certain Saturdays; occurs 7-8 times per year
- Curbside Cleanup Collection 2 curbside collections per year of up to 15 bags per collection; single-family and duplex households only
- Curbside Bulky Item Collection 1 curbside collection per year of 1 large item; single-family and duplex households only
- Household Hazardous Waste (HHW) –disposal of HHW at 101 Pittsburg Ave., Richmond (Wednesday-Saturday)
 - Mobile HHW Collection door-to-door collection of HHW for residents age 60 or older or residents with a disability; single-family and duplex households only
- Mattress Recycling disposal of old mattresses and box springs at 101 Pittsburg Ave., Richmond (Wednesday-Saturday)

Street Sweeping

- Residential streets swept twice per month (Attachment 1)
- Commercial streets swept four times per month (Attachment 1)

Material Source Control

- Plastic Bag Ban Ordinance 2013-009: Chapter 5.12 San Pablo Municipal Code Single-use plastic bag ordinance, effective January 1, 2014:
 - Single-use plastic bags may not be distributed in retail stores (e.g. supermarkets, clothing stores)
 - Retailers must charge customers a minimum of 10 cents for a paper bag or reusable plastic bag
 - Restaurants and take-out food establishments are exempt
- Plastic Foam (Polystyrene) Ban Ordinance 2014-013: Chapter 5.13 San Pablo Municipal Code Plastic foam ordinance, effective April 1, 2015:
 - Restaurants may not provide plastic foam foodware or takeaway containers
 - City facilities/events may not use plastic foam foodware or takeaway containers
 - Retail stores may not sell plastic foam products (excluding pre-packaged goods)

• 37 City-owned cameras (Attachment 2) in addition to cameras in the Del Camino government housing area and Giant Trade Center, which are owned by those properties but provide PD with full access to live feed and recorded camera footage.

C.O.R.E. Team

• The Coordinated Outreach Referral, Engagement (C.O.R.E.) program works to engage and stabilize homeless individuals living outside in Contra Costa County through consistent outreach to facilitate and/or deliver health and basic need services and secure permanent housing.

Litter Pick-Ups


- Public Works Department, Maintenance Division
 Collect 107 City-wide garbage bins twice a week and respond to illegal dumping incidents five times per week.
- EarthTeam

EarthTeam provides paid student internships to Richmond High students for environmental stewardship education, work-based learning opportunities, litter pickups and leadership training. The City has partnered with Earth Team to perform 30 litter removal events on Rumrill Blvd., San Pablo Ave., 23rd St. and Brookside Dr.

Kids for the Bay

Kids for the Bay provides watershed and trash education to students of Dover, Downer and St. Paul Elementary schools. Every October, the City partners with Kids for the Bay on a Wildcat Creek Cleanup Event where volunteers from these schools remove trash and debris from the Creek and Davis Park.

CITY OF SAN PABLO STREET SWEEPING MAP 2020


