RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SAN PABLO APPROVING A PROFESSIONAL SERVICES AGREEMENT WITH THE SAN PABLO ECONOMIC DEVELOPMENT CORPORATION FOR FY 2019/20 IN THE AMOUNT OF \$562,500 AND APPROPRIATING \$562,500 FROM GENERAL FUND DESIGNATED RESERVES/SPEDC OPERATING SUBSIDY TO FUND THE AGREEMENT

WHEREAS, Support for the San Pablo Economic Development Corporation is a policy priority in the adopted FY 2019-21 City Council Adopted Workplan, effective March 1, 2019;

WHEREAS, this is not a project as defined by CEQA, because it is a financing mechanism;

WHEREAS, in compliance with the Fiscal Resiliency Reserve Policy adopted on October 21, 2013, the City Council of the City of San Pablo finds that use of the General Fund Designated Reserves with earmarks of \$562,500 for the SPEDC FY 2019/20 Operating Subsidy from the Designated Reserves approved by City Council on January 21, 2020 as stated below is an appropriate and prudent use of these funds;

WHEREAS, in February 2011, the San Pablo Economic Development Corporation Board of Directors held its first meeting, elected officers, approved Articles of Incorporation, and adopted By-Laws, and since that time, the San Pablo City Council and the SPEDC have enjoyed a relationship of mutual support and trust based on common goals and objectives of enhancing job creation and training and facilitating business growth and opportunity;

WHEREAS, in recognition of these mutual goals and objectives in the economic development arena, the City Council has seen fit to provide financial subsidies and support to ensure the success of the SPEDC, and hence, the stability of the local economy;

WHEREAS, staff proposes entering into a professional services agreement with the SPEDC for services outlined in the attached scope of work for FY 2019/20 (effective July 1, 2019 - June 30, 2020) in the amount of \$562,500;

WHEREAS, on January 21, 2020, City Council approved the FY 2019/20 General Fund Designated Reserves with an earmark of \$562,500 for an SPEDC FY 2019/20 Operating Subsidy, but the funding still sits in the General Fund Designated Reserves and needs to be appropriated into the City Council's professional services budget for FY 2019/20 (100-1110-43600); and

WHEREAS, the City of San Pablo is legally obligated for seven years from completion of the Rumrill Sports Park project to ensure the continuation of the SPEDC due to financial requirements of the New Market Tax Credit financing.

NOW, THEREFORE, BE IT RESOLVED that the foregoing recitations are true and correct, and are included herein by reference as findings.

BE IT FURTHER RESOLVED that the City Council of the City of San Pablo approves an agreement with the San Pablo Economic Development Corporation in the amount of \$562,500 for services outlined in the Scope of Work for FY 2019/20, which is attached and incorporated as Exhibit A and authorizes the City Manager to execute it; and

BE IT FURTHER RESOLVED that the City Council of the City of San Pablo appropriates funding in the amount of \$562,500 from fund balance in the FY 2019/20 General Fund Designated Reserve/SPEDC to the FY 2019/20 City Council professional services budget (100-1110-43600) to support SPEDC activities.
