RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SAN PABLO ACCEPTING WORK PERFORMED BY GHILOTTI BROTHERS, INC. FOR THE SAN PABLO AVENUE COMPLETE STREETS PROJECT (SPA-CST) AS COMPLETE AND DIRECTING THAT A NOTICE OF COMPLETION BE PREPARED AND FILED WITH THE COUNTY RECORDER

WHEREAS, the San Pablo Avenue Complete Streets Project addresses a need for safe multimodal facilities on a major arterial, San Pablo Avenue between Rumrill Boulevard in the City of San Pablo and La Puerta Road in the City of Richmond;

WHEREAS, City of San Pablo was awarded \$5.978 million in One Bay Area Grant (OBAG) funds for the San Pablo Avenue Complete Streets Project while the design and environmental review and construction management/inspection were jointly funded by the City of San Pablo and the City of Richmond, each contributing \$615,000;

WHEREAS, pursuant to Resolution 2015-058, the City Council approved the grant matching funds in the amount of \$1,230,000 jointly funded by the City of San Pablo and the City of Richmond for the San Pablo Avenue Complete Streets Project;

WHEREAS, pursuant to Resolution 2018-019, the City Council authorized a construction contract with Ghilotti Brothers, Inc. for construction and approved the funding allocation of \$5,812,093;

WHEREAS, pursuant to Resolution 2019-090, the City Council authorized contract change orders and amended the contract with Ghilotti Brothers, Inc. by \$250,987;

WHEREAS, the project was completed for a final construction cost of \$5,970,485.31;

WHEREAS, the City Engineer has determined that the above work has been completed in accordance to the plans and specifications;

WHEREAS, with the closing of the project, the remaining balance of approximately \$158,655 will be returned to source (the General Fund) per best management practices; and

WHEREAS, the City is holding 5% retention on this project. When the Notice of Completion is approved, the City will pay out the retention and close out the project.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of San Pablo hereby:

1. Accepts work performed by Ghilotti Brothers, Inc. for the San Pablo Avenue Complete Streets Project (SPA-CST) as complete.

2. Directs that a Notice of Completion be prepared and filed with the County Recorder for the San Pablo Avenue Complete Streets Project (SPA-CST).
