SUMMARY OF PROPOSED ORDINANCE OF THE CITY COUNCIL OF THE CITY OF SAN PABLO AMENDING MUNICIPAL CODE SECTIONS 1.16.020, 2.16.020, 8.02.070, 10.28.030 AND 15.48.070 REGARDING THE LOCATION OF CITY HALL; REPEALING CHAPTERS 2.24 AND 2.36 RE-GARDING THE COMMUNITY SERVICES COM-MISSION AND DISASTER COUNCIL; REPEALING SECTION 2.04.040 AS REDUNDANT; AND AMENDING SECTION 9.10.100 REGARDING PER-MITS TO SELL FIREREMS

The following is a summary of major highlights of the ordinance; a reading of the entire ordinance mance may be necessary to obtain a full understanding of all changes. The ordinance was introduced at the City Council meeting of March 2, 2020 and is scheduled for adoption at the March 16, 2020 City Council meeting. The ordinance primarily updates the address for City Hall, as well as for the Police Department; repeals a duplicative provision; eliminates references to the Community Services Commission and Disaster Council, which no longer exist; and updates the address and indemnity for the permit process for selling firearms.
