CITY COUNCIL RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SAN PABLO AFFIRMING REVISED RECOMMENDED APPOINTMENTS BY MAYOR ARTURO CRUZ OF INDIVIDUAL CITY COUNCIL STANDING COMMITTEE AND REGIONAL/LOCAL ASSIGNMENTS FOR CALENDAR YEAR 2020

WHEREAS, all City Councilmember assignments to newly established Temporary Ad-Hoc Subcommittees, Standing Committees, and Regional/Local Bodies for Calendar Year 2020 must be affirmed each calendar year in accordance with San Pablo Municipal Code (SPMC) 2.16.070, where applicable;

WHEREAS, per SPMC 2.16.070, the Mayor has made all recommendations of City Councilmembers to said City Council Standing Committees and Regional/Local Bodies for Calendar Year 2020 listed under Exhibits A and B attached hereto;

WHEREAS, following City Council deliberation, the City Council adopted Resolution 2020-011 which affirmed all Mayor recommendations on establishment and re-constitution of all City Council Temporary Ad-Hoc Subcommittees and Standing Committee changes listed under Exhibits A and B for Calendar Year 2020; and
