## RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SAN PABLO AUTHORIZING AN EVENT SPONSORSHIP IN THE AMOUNT OF \$2,500 FOR THE 2020 WEST CONTRA COSTA SALESIAN BOYS & GIRLS CLUB CHARITY GOLF TOURNAMENT FUNDRAISER ON MONDAY, SEPTEMBER 21, 2020

WHEREAS, Build a Healthy Community: Foster Youth Leadership/Cultivation of the next generation of civic leaders is an adopted policy item in the FY 2019-21 City Council priority Work plan, effective March 1, 2019 as last amended on September 8, 2020;

WHEREAS, this is not a project as defined by CEQA;

WHEREAS, On August 13, 2020, the City Manager's Office received a request from Joseph Aita, West Contra Costa Salesian Boys and Girls Club (WCCSBGC) President, announcing their annual golf tournament;

WHEREAS, the event will be held at the historic Richmond Country Club on Monday, August 26, 2019, and the tournament is their most significant fundraising event;

WHEREAS, for the past 73 years, the WCCSBGC has remained dedicated to ensuring that underserved children and teens in the communities of San Pablo and Richmond have access to quality after-school and summer programs that enhance their lives and shape their future;

WHEREAS, each year, over 3,300 youth participate in a broad range of programs in five core areas: Character and Leadership Development, Education and Career Development, Health and Life Skills, the Arts and Sports, and Fitness and Recreation; in addition to receiving daily tutoring and homework assistance.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of San Pablo approves a sponsorship in the amount of \$2,500 for the annual West Contra Costa Salesian Boys & Girls Club Annual Charity Golf Tournament Fundraiser; and

BE IT FURTHER RESOLVED that a total of \$25,000 has been budgeted and earmarked for Event Annual Sponsorship for F Y2020/21 under the Adopted FY 2018-21 Quadrennial Operating Budget – City Council Division (100-1110-44050). The authorized sponsorship in the amount of \$2,500 will be deducted from this expense balance leaving a remaining balance of \$22,500 for the remainder of FY 2020/21 period for future sponsorships by the City Council.
