RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SAN PABLO CITY COUNCIL AMENDING THE FY 2021-23 ADOPTED CITY COUNCIL PRIORITY WORKPLAN UNDER MAJOR POLICY GOAL: BUILD A HEALTHY COMMUNITY TO ADD A NEW POLICY AMENDMENT: RESEARCH/EXPLORE EFFORTS AT THE FEDERAL, STATE AND LOCAL LEVEL REGARDING A MINIMUM/LIVING WAGE INCREASE FOR SAN PABLO BUSINESSES AND WORKERS

WHEREAS, at a Special Meeting/Workshop on February 10, 2021, the City Council spent an afternoon discussing and establishing City priorities for the coming year beyond the daily operational and legal requirements for the City;

WHEREAS, on March 15, 2021, following a rescinding of previous adopted Resolution 2021-018, the San Pablo City Council adopted a revised City Council Priority Workplan (Workplan) for period FY 2021-23 via adopted Resolution 2021-026;

WHEREAS, for the Council to consider mid-year amendments to the Priority Workplan to add additional policy items requires a Two-Step Process to support the interests of open government and transparency and to ensure ongoing compliance with the Ralph M. Brown Act;

WHEREAS, since its formal adoption on March 15, 2021, there have been no policy amendments approved by majority vote via Resolution to date;

WHEREAS, at the March 1, 2021 City Council meeting, on motion made by Councilmember Pineda, duly seconded, the City Council authorized by majority vote to agendaize a policy discussion at the April 5, 2021 City Council meeting to potentially consider adding the following policy amendment to be added to the adopted FY 2021-23 Council Priority Workplan (Workplan); and

WHEREAS, following City Council policy discussion, the City Council desires to formalize this amendment to the Workplan and to direct the City Manager to conduct additional policy research and/or develop specific policy recommendations related to this adopted policy amendment for subsequent formal discussion and approval by the City Council in the near future.

NOW THEREFORE, BE IT RESOLVED the City Council of the City of San Pablo authorizes the following addition to the Priority Workplan :

1. **Proposed Workplan Policy Amendment for City Council Discussion:**

MAJOR POLICY AREA: BUILD A HEALTHY COMMUNITY

Add/New: Policy Item #115:

Research and explore efforts at the Federal, State and Local level regarding a Minimum/Living Wage Increase for San Pablo workers and businesses

BE IT FURTHER RESOLVED that the foregoing recitations are true and correct, and are included herein by reference as findings.
