

RESOLUTION 2021-112

RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SAN PABLO (1) AUTHORIZING THE CITY MANAGER TO PURCHASE ONE (1) 2021 FORD F-650 CHASSIS, ELECTRIC BATTERY POWERED GARBAGE TRUCK FROM ELECTRIC VEHICLE CONVERSIONS IN SANTA FE SPRINGS, CA; (2) WAIVING THE COMPETITIVE BIDDING REQUIREMENTS FOR THE PURCHASE PURSUANT TO THE SAN PABLO MUNICIPAL CODE SECTION 3.16.110; (3) RATIFYING THE APPLICATION FOR FUNDING THROUGH CALIFORNIA'S HYBRID AND ZERO-EMISSION TRUCK AND BUS VOUCHER INCENTIVE PROJECT; AND (4) APPROPRIATING \$220,000 FROM THE GENERAL FUND DESIGNATED RESERVES TO THE VEHICLE REPLACEMENT FUND TO EXECUTE PUBLIC WORKS VEHICLE PURCHASES IN FY 2021/22

WHEREAS, the City's garbage truck requires replacement;

WHEREAS, City staff recommends purchasing a Ford F-650 chassis, electric battery powered garbage truck from Electric Vehicle Conversions (EVC) in Santa Fe Springs, CA for a total amount of \$305,205;

WHEREAS, the City and EVC jointly applied to the Hybrid and Zero Emission Vehicle Incentive Program (HVIP) administered by the California Air Resources Board (CARB);

WHEREAS, a voucher in the amount of \$93,500 will be provided to EVC to apply to the purchase price of the vehicle, leaving the City to pay the balance of \$211,705;

WHEREAS, the unique nature of this product allows the City to dispense with standard quotation or bidding process pursuant to the San Pablo Municipal Code Section 3.16.110 as a hybrid "sole source" agreement, "cooperative purchasing" agreement (through the limited number of vendors established by CARB), and "specialized services combined with equipment and/or products" exceptions;

WHEREAS, on July 21, 2021, staff presented this request to the Public Safety Standing Committee and upon completion the Standing Committee recommended the request be forwarded to the City Council for review and approval;

WHEREAS, the City's share of the purchase price of the vehicle is \$211,705, and other appurtenances will cost an additional \$20,000 for a total of \$231,705; and

WHEREAS, \$220,000 of this will be funded from the City's General Fund Designated Reserve and \$11,705 will be funded from the Property Maintenance operating budget.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of San Pablo waives the competitive bidding requirements and authorizes the City Manager to execute an agreement with Electrical Vehicle Conversions in the amount of \$211,705 for an electric Ford F-650 chassis, SEA electric power drive and EV Conversions garbage unit; and

BE IT FURTHER RESOLVED that the City Council ratifies the HVIP application submitted on August 5, 2021 by EVC on the City's behalf; and

BE IT FURTHER RESOLVED that the City Council authorizes the City Manager to appropriate \$220,000 from the General Fund Designated Reserve (100-0000-00000) to the spendable account for Property Maintenance Equipment Purchase (100-3410-46300) to fund the vehicle purchase and outfitting;

BE IT FURTHER RESOLVED that the foregoing recitations are true and correct and are included herein by reference as findings.
