RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SAN PABLO AUTHORIZING THE CITY MANAGER TO (1) APPROPRIATE MEASURE J FUNDING IN THE AMOUNT OF \$20,000 FOR THE GIANT ROAD PAVEMENT REPAIR PROJECT (0601), AND (2) EXECUTE A CONTRACT AMENDMENT WITH TREMAINE & ASSOCIATES, INC. IN THE AMOUNT OF \$5,608 WITH A 15% CONTINGENCY FOR A TOTAL AUTHORIZATION OF \$27,128 TO CONDUCT AN ENVIRONMENTALLY SENSITIVE AREA ACTION PLAN AND HISTORIC PROPERTY SURVEY REPORT

WHEREAS, the City of San Pablo, in coordination with the California Department of Transportation (Caltrans), District 4, proposes to repair a section of Giant Road between Brookside Drive and Trenton Boulevard;

WHEREAS, the Giant Road Pavement Repair Project (0601) will be federally funded by One Bay Area Grant (OBAG);

WHEREAS, the Giant Road Pavement Repair Project will rehabilitate street pavement with an overlay and slurry seal, upgrade curb ramps to current Americans with Disabilities Act (ADA) standards, replace striping, and eliminate sidewalk hazards;

WHEREAS, the Giant Road Pavement Repair Project lies within the Lower San Pablo Creek Archaeological District and at least two prehistoric sites are known situated in the nearby vicinity;

WHEREAS, Caltrans required an Archaeological Survey Report (ASR) and Extended Phase I (XPI) Report to determine if the project will have an effect on the Lower San Pablo Creek Archaeological District;

WHEREAS, on January 12, 2021, the City of San Pablo entered into an agreement with Tremaine & Associates, Inc., to prepare an ASR and XPI Report for the Giant Road Pavement Repair Project;

WHEREAS, based on the XPI Report findings, Caltrans is requiring an Environmentally Sensitive Area Action Plan (ESA-AP) and a Historic Property Survey Report (HPSR) for the project;

WHEREAS, Tremaine & Associates, Inc., provided a proposal to complete an ESA-AP and HPSR for the Grant Road Pavement Repair Project, which City staff found reasonable;

WHEREAS, City staff recommends executing a contract amendment with Tremaine & Associates, Inc. in the amount of \$5,608 with a 15% contingency for a total authorization of \$27,128; and

WHEREAS, City staff recommends appropriating Measure J funds in the amount of \$20,000 for costs associated with this contract amendment, unforeseen grant match requirements, and future archeological studies.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of San Pablo authorizes the City Manager to execute a contract amendment with Tremaine & Associates, Inc., in the amount of \$5,608 with a 15% contingency in the amount \$842 for a total authorization of \$6,450 to conduct an Environmental Sensitive Area Action Plan and Historic Property Survey Report for the Giant Road Pavement Repair Project; and

BE IT FURTHER RESOLVED that the City Council authorizes the City Manager to appropriate Measure J funds in the amount of \$20,000 for the purpose of archeological studies and grant match requirements for the Giant road Pavement Project.
