RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SAN PABLO (1) APPROVING THE MULTI-UNIT DWELLINGS ILLEGAL DUMPING ENFORCEMENT PILOT PROGRAM; (2) AUTHORIZING AN APPLICATION FOR THE HYBRID AND ZERO EMISSION VEHICLE INCENTIVE PROGRAM FOR AN ELECTRIC TRUCK; AND (3) APPROPRIATING \$300,000 FROM GENERAL FUND DESIGNATED RESERVES AS FOLLOWS: \$240,000 TO THE PROPERTY MAINTENANCE VEHICLE REPLACEMENT FUND, \$50,000 TO THE STREET MAINTENANCE FUND, AND \$10,000 TO THE ENVIRONMENTAL SERVICES FUND IN FY 2021-22

WHEREAS, litter and illegal dumping have been identified as a major issue of concern for the City of San Pablo (City) despite several programs available to residents;

WHEREAS, the City Council identified litter and illegal dumping as a Council Priority Workplan Policy and an internal Litter and Illegal Dumping Task Force made up of staff from various departments was established by the City Manager;

WHEREAS, the Task Force recommended various programs, outreach, infrastructure, and enforcement activities to help alleviate littering and illegal dumping;

WHEREAS, staff have identified multi-unit dwellings (MUDs) as a hot spot for illegal dumping and propose an enforcement pilot program in accordance with the Task Force's recommendations;

WHEREAS, the MUD pilot enforcement program will include extensive outreach prior to issuing notices, and after 6 months will be evaluated to determine if it is successful;

WHEREAS, costs necessary to fund the pilot program include approximately \$240,000 for a tink claw bucket for the exiting loader and for an electric truck, \$50,000 to hire two part-time staff to pick up the illegally dumped items for 6 months, and \$10,000 for outreach costs; and

WHEREAS, staff will apply for the next cycle of the Hybrid and Zero Emission Vehicle Incentive Program in the fall for an electric truck.

NOW, THEREFORE, BE IT RESOLVED that the foregoing recitations are true and correct, and are included herein by reference as findings; and

BE IT FURTHER RESOLVED that the City Council of the City of San Pablo hereby approves the MUD illegal dumping enforcement pilot program; and

BE IT FURTHER RESOLVED that the City Council of the City of San Pablo hereby authorizes an application for the Hybrid and Zero Emission Vehicle Incentive Program for an electric truck; and

BE IT FURTHER RESOLVED that the City Council of the City of San Pablo hereby appropriates \$300,000 from General Fund Designated Reserves for Fiscal Year 2021-22, as summarized in the below table.
