

# Minutes of the Regular Meeting of the San Pablo City Council and the Local Successor Agency

Monday, September 16, 2019

## **ROLL CALL**

The meeting reconvened in the Council Chambers at 6:01 pm. Present were Mayor Rich Kinney and Vice Mayor Arturo Cruz, who participated via teleconference, and Councilmembers Elizabeth Pabon-Alvarado, Rita Xavier and Abel Pineda. It was confirmed by Vice Mayor Arturo Cruz that the agenda was posted at his location a minimum of 72 hours prior to the meeting. No members of the public were present at the teleconference location desiring to participate in the meeting. Also present were City Manager Matt Rodriguez, City Attorney Lynn Tracy Nerland, Assistant City Manager Reina Schwartz, Police Chief Ron Raman, Administrative Services Director Kelly Sessions, Public Works Director/Civil Engineer Jill Mercurio, City Treasurer Viviana Toledo, City Clerk Patricia Ponce, and Executive Assistant to the City Manager LaTanya Fisher.

- 7. By adoption of the Consent Calendar, **Resolution 2019-141** was adopted, a Resolution of the City Council of the City of San Pablo approving a sponsorship in the amount of \$5,000 for North Richmond Shoreline Festival on Saturday, October 12, 2019. (#19-408)
- 8. By adoption of the Consent Calendar, **Resolution 2019-142** was adopted, a Resolution of the City Council of the City of San Pablo authorizing a sponsorship in Fiscal Year 2019/20 in the amount of \$2,500 for the Contra Costa College Foundation San Pablo Scholars Scholarship Program. - 9. By adoption of the Consent Calendar, **Resolution 2019-143** was adopted, a Resolution of the City Council of the City of San Pablo (1) authorizing the emergency procurement and installation of HVAC equipment for the Police Administrative Facility (4/5 VOTE); (2) awarding the bid to SH Mechanical, Inc. for the purchase of a 20-ton "Carrier" Rooftop Cooling Unit, to include equipment, hardware, ancillary installation and a one-year warranty, at the Police Department in the amount of \$67,825 including a 15% contingency for a total not to exceed \$77,999; and (3) authorizing the City Manager to enter into an agreement with SH Mechanical, Inc. (#19-412)
- 10. By adoption of the Consent Calendar, **Resolution 2019-144** was adopted, a Resolution of the City Council of the City of San Pablo authorizing the City Manager to execute amendments for the design of the Rumrill Boulevard Complete Streets Project and to amend the existing agreement with Nichols Consulting Engineers, Inc. by \$650,471 for a new total of \$1,435,451 with a 15% contingency of \$215,317 for a total authorization not to exceed the new total \$1,650,768. - 11. By adoption of the Consent Calendar, **Resolution 2019-145** was adopted, a Resolution of the City Council of the City of San Pablo declaring October 2, 2019 as *California Clean Air Day.* (#19-392)
- 12. By adoption of the Consent Calendar, **Resolution 2019-146** was adopted, a Resolution of the City Council of the City of San Pablo approving an application for Contra Costa County Census 2020 Outreach and Assistance Grant. (#19-419)
