

City of San Pablo Planning Commission Minutes

Roll Call

Vice Chair Gurdian called the teleconferenced/video-conferenced meeting to order at 6:05 p.m. Roll call showed present: Commissioner Morris, Commissioner Jackson and Vice Chair Gurdian. Chair Feliciano and Commissioner Owens were absent. Staff present at the meeting included: Teresa Stricker, City Attorney; Libby Tyler, Community Development Director; Griffen Dempsey, Assistant Planner; and Michelle Chavez, Administrative Secretary. Community Development Director Tyler announced that the meeting was being held via video/teleconference in accordance with the Brown Act, as amended by Assembly Bill 361, and following a determination of the City Council pursuant to Resolution 2022-140. Ms. Tyler further announced the ways in which members of the public could watch or listen to the meeting during livestream on the City website, which were also highlighted in the Planning Commission's agenda.
