The First Draft Housing Element was posted on the City's website on August 19, 2022 for a public review period of 30 days. September 19, 2022 the City Council will review the First Draft Housing Element and hold a public hearing. The First Draft Housing Element will be submitted to HCD (California Department of Housing and Community Development) by September 30, 2022 for a 90 day review. The Planning Commission and City Council will hold public hearings for final adoption in Spring of 2023. The public hearing opened at 6:51pm and closed at 6:52pm as there were no public
