BACKGROUND

On November 30, 2017 Rafael Torres, President of San Pablo United Youth Soccer Club (SPUYSC), submitted a letter of request to the City Manager requesting the waiver of fees for El Portal Soccer Field:

- El Portal Soccer Field from July 16, 2018 thru November 10, 2018
 - Monday Friday from 4:00 PM 8:00 PM

• Saturday and Sunday from 8:00 AM - 5:00 PM

SPUYSC is a volunteer-run, non-profit organization dedicated to the youth and families in the City of San Pablo. They provide the opportunity to play soccer to approximately 200 boys and girls ages 3 to 18 years. Through the sport of soccer, the SPUYSC has been able to increase active healthy participation for participants in an outdoor environment. SPUYSC has also been able to promote sportsmanship, leadership and teambuilding skills.

The SPUYSC is attempting to reassure families that by being in partnership with the City of San Pablo that children will be protected regardless of their religion, race, gender, or immigration status and that no children are left behind due to socioeconomic disadvantages.

FISCAL IMPACT

The fiscal impact for FY 2018/19 (2018 summer/fall season) will be subsidizing approximately \$5,360 in rental revenue for El Portal Soccer Field.
