**BACKGROUND**

The City of San Pablo pays an annual membership fee to the League of California Cities which is an annual budgeted expense in the FY 2018-2021 Quadrennial General Fund Adopted Budget. The membership fees generally provide all local cities the following benefits/services, as follows:

- Unmatched Advocacy to the State Legislature and State Courts
- Timely Communication
- League Member Driven Priorities
- Best Local Government Practices
- Cutting-Edge Professional Management
