### **BACKGROUND**

The City Council must designate one voting delegate and may authorize up to two alternates.

The League's delegation procedures are intended to ensure the integrity of the voting process at the Annual Business Meeting. At this time, both Mayor Xavier and City Attorney Stricker are registered to attend the Conference.
